### **Standard Warranty Terms**

The terms and conditions of this warranty shall apply to the provision of warranty service by Spartan Apparel LLC to the Charge, Force, Retro, Elite and SL-1 suits, and Charge, Cafe Racer and Traveler jackets. The warranty service shall be effected at such a place as Spartan Apparel LLC may elect, or through authorized Agents.

If, within the applicable Warranty Period as set out in Paragraph 11 below, ("The Warranty Period"), and any of the Products proven to be defective by reason of faulty workmanship or materials, Spartan Apparel LLC undertakes, with reasonable promptness, to have the defective product (or any part /s thereof) repaired, or at their discretion replaced free of charge by them or by one of their authorized Agents, subject to the following terms and conditions.

1. The product shall have been used solely for its normal purpose and used and maintained in accordance with standard instructions of practice.
2. This Warranty only extends to the original purchase ("the Purchaser") who, when requesting warranty service must simultaneously with the request present the applicable and valid purchase receipt to Spartan Apparel LLC. Failure to produce the applicable and valid purchase receipt will result in the request for warranty being null and void.
3. After replacement or repair of the Products, the Warranty for the new or repaired Product shall be only for the non-expired period of the original Warranty Period.
4. Spartan Apparel LLC reserves the right to charge the Purchaser if any warranty service is requested and carried out but where no fault is found with the Product.
5. The following are expressly excluded from this warranty:
  - 5.1 Maintenance services; e.g. correct treatment as per recommendations
  - 5.2 Consequential damages resulting from any defect in the product
  - 5.3 Transportation costs of any product found to be defective, though Spartan Apparel LLC may, at its own discretion, assist with it.
6. Spartan Apparel LLC shall not be responsible for any delay in repairs in the even that any parts necessary for the warranty servicing of the Product is not in stock.
7. The Warranty shall not apply to malfunction or damage resulting from accidents, which occur during use, transit and/or handling. Product misuse, improper use, abuse, neglect or negligence by the purchaser or anybody else, use inconsistent with the technical and/or safety standards, malfunction or damage due to fire, earthquake, flood, lightning or any external disaster, war or any other disturbance. Unforeseen accidents, wear and tear, or any other external factors beyond Spartan Apparel LLC's

control or to any product repaired, altered, modified or converted by any person (including the Purchaser) other than Spartan Apparel LLC.

8. If at any time during the Warranty Period, any part of the product is replaced with a part or material not supplied or approved by Spartan Apparel LLC, or the product has been dismantled or repaired by a person not authorized by Spartan Apparel LLC, the Purchaser shall not be entitled to any rights and or remedies under this warranty.

9. The Purchaser's sole and exclusive remedy under this warranty against Spartan Apparel LLC is for the repair (or at Spartan Apparel LLC's discretion, the replacement) of the Product or any part /s and no other remedy, including but not limited to, incidental or consequential damage or loss of whatsoever nature, shall be available to the Purchaser.

10. Spartan Apparel LLC's decision on all matters relating to complaints shall be final and binding on the Purchaser.

11. The Warranty Period applicable to Spartan Apparel LLC Products shall be

- Café Racer Jacket 3 (three years)
- Traveler Jacket 3 (three years)
- Charge 1pc or 2pc Suit and Jacket 3 (three years)
- Force 1pc or 2pc Suit and Jacket 3 (three years)
- Retro 1pc or 2pc Suit and Jacket 3 (three years)
- Elite 1pc or 2pc Suit and Jacket 5 (five years)
- SL-1 1pc or 2pc Suit Lifetime

12. Any defective Products or part/s, which have been replaced, shall become Spartan Apparel LLC's property.

13. Spartan Apparel LLC does not give any warranty or guarantee whatsoever in respect of any product (or any part/s thereof) which as not been manufactured or imported and distributed by Spartan Apparel LLC, and which has not been purchased from an authorized dealer

14. Spartan Apparel LLC does not make any representations or warranties, express or implied with respect to the Products, including without limitation any implied warranties of fitness of a particular purpose, except as expressly set forth herein. In no event shall Spartan Apparel LLC be liable to the user for any lost products or for special damages, indirect loss or any other damage.

15. No authority has been given to anyone whomsoever to vary the terms or conditions of this Warranty.
